Cabin Rental Agreement

Welcome to Wind Point Park. We want your stay in our cabins to be safe and enjoyable. As such, the following rules are in place:

- NO SMOKING IN CABIN
 Surrender of deposit + \$250 charge will be billed to credit card on file.
- No fish or fowl cleaning allowed at the cabins. There is a fish cleaning station provided on-site.
- No grease down the drain only toilet paper down the toilet.
- Wind Point Park welcomes your pet. A fee of \$35 per night for pets will be assessed on cabin rentals and you must sign a pet policy. The maximum number of pets allowed is 2. Please crate you pets when not at site.
- No tents allowed in the cabin area.
- Campfires are only allowed in the fire ring. Please do not leave fire unattended and the fire must be completely put out before retiring in the evening.
- Cabin furniture, including dining room table and chairs, is to remain inside at all times. Porch furniture must remain on the porch.
- Do not remove batteries from the smoke alarms.
- The cabin must be left in an orderly fashion, leaving it dirty or in disarray may result in loss of the security deposit.
- Check out is at 11am. Please return the key to the office. Failure to return the key will result in a \$25.00 charge that will be deducted from the security deposit.

Wind Point Park welcomes your pet(s). A fee of \$35 per night for pets will be assessed on cabin rentals. Maximum pets allowed is 2. This is applicable to all cabins.

The type of pet(s) are limited to domestic animals only, such as a dog or a cat. Guests must also comply with local laws and ordinances, including those related to animals that are considered vicious or have a reputation for being dangerous.

THERE ARE CERTAIN RULES THAT NEED TO BE FOLLOWED DURING YOUR STAY TO ENSURE THE SAFETY OF ALL OF OUR GUESTS.

- Pet(s) shall remain within your control at all times, either on a leash or in a carrier. Pets may remain alone in the cabins as long as the pet is crated. However, if your pet is disturbing other guests/staff or causing damage, then it cannot be left alone and must remain in your control.
- Pets cannot be left outside overnight.
- Cat owners shall provide a litter box for their pet.
- Guest is responsible for cleaning up after their pets inside cabins and outside. Failure to comply will result in loss of your security deposit.
- Wind Point Park shall be entitled to reimbursement if damages are incurred or if excessive cleaning is necessary as result of a pet. Costs incurred will be withheld from your security deposit. Costs incurred above the amount of the security deposit will be charged to the credit card on file for the reservation.
- Wind Point Park may, in its sole discretion, require any guest with a pet to find other accommodations immediately if it deems the pet(s) to be dangerous, harmful or disruptive to staff, property, or other Wind Point Park guests. Wind Point Park further reserves the right to call animal control to have the pet removed if the pet is not being controlled by the owner.
